<p>The purpose of the Safe Schools Advisory Council (SSAC), as set forth by the Prince William County School Board (School Board), is to support the safety and security of students, staff, and schools through the review and discussion of general, Divisionwide or level-wide (elementary, middle, and high schools) policy questions, issues, and concepts raised by parents, SSAC members, the administration, the Prince William County Schools' Superintendent (Superintendent), the School Board, or the community at-large. Additionally, the SSAC is to further enhance the working relationship between Prince William County Public Schools (PWCS), other governmental agencies, and the community, on topics that relate to the safety of students, staff, and schools, within the scope of existing School Board policies and Division regulations and to serve as a review committee for specific audits and safety related reports as deemed appropriate. Such reviews shall not include information pertaining to specific students (refer to bylaws for full scope of the SSAC).</p>
