Christine Chesarek – Issues with registering students ages 16 - 17 to get vaccinated. Students under 18 can only receive Pfizer and the location they are sending students will not vaccinate those under 18. There is a problem with the system.

Denise Huebner: Update on Vaccines for for those 16 and over with chronic health conditions: I have confirmed with Dr. Ansher and a healthcare administrator from Novant UVa Healthcare team that we are willing to support this as a School Division. We will be working with Novant to determine next steps on how we can support our PWCS family and community members. Our Division will be supporting Novant during the second week of April and I am confident that we can work with families to support the vaccination process.

Tara Aqdas- Follow up about vaccine availability for students for the fall. This could impact students learning setting in the fall. Denise Huebner responded that the county is working with Novant Health.

Alana Walmsley and David Williams – Presentation on Project SEARCH - Eight – Ten students are chosen to participate each year. Job placement after completing the program is in the 80% range. The program has looked different this year due to COVID. Students get one day of learning and 4 days on an internship site. This year, due to the pandemic, it started with food bank. Currently the participants are at True Hotel. On April 6, they will be allowed to be back in the hospital. Students can work in the labs, the kitchen, the grounds, and other additional opportunities to learn different job sets. The county has around 100 different partnerships within the county to provide opportunities for students. Transition Fair this coming Saturday at 11:00. It will be recorded.

- b. O & A with Heather Grim, Janice Hornbeck and Jennifer Lee Related Services
- -How would COVID recovery services work? Covid recovery services would be determined by the IEP team.
- -What would related services look like at a younger age? How do they qualify for related services? Students qualify for OT/PT the team would meet and review the results and make a determination as a team. This would be at an IEP meeting. Students qualify for speech and it can be a primary or secondary disability. It can also be related services.

What happens when students don't qualify for services, but parents believe that they need services? We go back to the intervention team and put some interventions in place. Related services can consult with teachers. Parents can request a central office review (COR) or Independent Educational Evaluation (IEE). It's hard to compare kids. Need to look at each student's individual and how to best serve each child. The COVID impact will last and need to discuss this with your IEP team.

Who is in charge of related services? Administration or central office? Principals often forward positive emails from parents to central office. Connie Mills is a coordinator.

Related services are able to order supplies for virtual learning. (Document cameras, laptops, headsets, microphones, etc.) Also, able to purchase equipment for students at home as needed. Sign Language interpreters have been able to access the equipment, as well. Given materials to keep lessons interactive. SLPs were provided virtual supports including LessonPix, LanguageLab, Ultimate SLP, SuperDuper, SLPAssists (Teach Town add on).

Related services could be mental health services. How can we prepare students to go back to the class 5 days a week after virtual learning? This will be a focus for related services. Plus 7 more psychologists and requesting more social workers as well.

What to do to encourage families to reach out for related services who don't want to it until the student is back in person.? The earlier the intervention the better.
