## I. Opening of meeting:

Call to Order: Jaime Van EchoMeeting opens at 1903Approval of October Minutes:

- Beverly motioned to accept minutes, Kristie seconded, minutes accepted Citizen Time:
  - At every meeting of the SEAC, an opportunity is provided for visitors to make public comment. It is received without SEAC comment. The public comment is summarized in the SEAC meeting minutes. The SEAC is always looking for ideas and suggestions from students, parents and teachers that will improve the education of children with disabilities. The SEAC requests that any concerns expressed include general comments dealing with global issues rather than a specific comment dealing with a personal matter or situation. The Committee suggests that you address concerns about personal situations directly to the Office of Special Education.   - Sandra Kern, Potomac District, happy to be through 1st quarter and concerned about starting 2nd quarter, struggling with online learning... hoping that SEAC will come forward for parents with a bold statement for parents/students who are struggling with online learning/canvas. Feels services aren't filled to the level necessary for all students online/virtually. She feels teachers have been "tremendous" with the tasks placed before them however. Thanks SEAC for giving parents the opportunity to speak out here as well. She feels children need these basic life skills like reading and writing so they can read a recipe, etc, to get through their daily lives.

• Tara Aqdas, Brentsville District, she has seen things from many different perspectives, knows teachers, knows many parents of children with varying ability levels. Some positive areas/successful ways to help are to use breakout sessions for one on one supports. Besides parents working on their own virtually, maybe we need some social time virtually for kids who are special needs as well as gen-ed and thinks that would be helpful. Teachers could ask more questions about their lives one on one because our students' home lives affect their education even more so virtually now. The biggest complaint she has heard from the community is that there are too many assignments.

### III. Kim Legault-Early Intervention/Child Find

Moved into Woodbine Center, have new office assistant and other new staff, have 9 evaluators and 11 teachers. Stepped into 21st century and are tracking students electronically and are storing data on students on one-drive...makes it much easier to keep tabs on everything for each student. Working to get registration online, cases are tracked via excel spreadsheet, we are teaching how to do evaluations/screenings virtually. Children who do not do well virtually are still being seen in person, have had in-person learning since september 8th if parents chose that over virtual. Students who are receiving virtual instruction are demonstrating that they are learning, however, some who seem to be struggling are coming into woodbine for one-on-one now as kind of an experiment. Teachers are using zoom, canvas and flipgrid and teachers are also going to homes to drop off materials for students to use WHILE learning virtually. We also have provided materials at 2 giveaways...teachers were surveyed about what materials they needed and many people shopped all over, online and at stores to provide those resources....just excited about opportunity to make a difference in lives of students and families and preschool in general.

- Jaime--question, there are 691 students currently, is the number of students enrolled now similar to the number enrolled this time last year?
  - Answer--evaluators are hard at work trying to complete evaluations, so it's hard to say right now because they have a backlog right now and should be caught up by December
  - o Beverly--had a similar question
- Jaime--you said that you are experimenting with bringing some kids into Woodbine for one-on-one, what does that look like and how do you identify who needs that extra help?
  - Answer--the way we identify is by the teacher having concerns, so the IEP team would pull in their team and also have discussion with their coordinator about the student's progress, they have 5 rooms that are supposed to be for testing but they are using them for this one-on-one service and the student has to come in with the parent and the parent is part of the lesson plan and they try to recreate the home environment in a way so the parent or parents can work with the teacher and the student
- Joi--RE canvas/flipgrid, how are you engaging parents/families to make sure they know how to use this technology?
  - Answer--we have first, worked with teachers to make sure they know how to use this technology so many families are experienced from the spring, we have provided laptops to many families as well, a couple of our families are having issues, we have a lot of support, if they are at the schools they have a lot of support
