IV. **Office of the Ombudsman** Sarah Miller Espinosa, J.D., is privileged to serve as PWCS's first Ombudsman. She joined the school division in August 2019. Prior to joining PWCS, Sarah established the Office of the Ombuds at Montgomery College, a multi-campus community college in Montgomery County, Maryland. Over the past twenty years, she has overseen labor and employee relations programs in the public sector, mediated workplace, and regulatory disputes, and served as an arbitrator, conducting hearings and issuing decisions. She joined about 15 months ago. Any member who has a division related concern can confidentially come and talk about that concern. A member is any student, teacher, parent, or anyone related in any way to the school division. She is impartial. She does not get involved in formal complaints and makes sure everyone has all the information about how to do a formal complaint if you need that. She is an attorney but does not practice law in this role. She is an obligated reporter so if the complaint or concern is about potential child abuse then she does have to report that.
